Subject: **Domestic agreements of the Issuer's subsidiary.**

Legal basis: Law on Offer, Art. 56, Par.1 Item 2– current and periodic information

Contents of the report:

Management Board of KOPEX S.A. with a registered seat in Katowice (the Issuer) informs that today has been aware of receiving on 15 March 2010 by WAMAG S.A. with a registered seat in Wałbrzych (the Issuer's subsidiary) 5 agreements signed with Kompania Węglowa S.A. with a registered seat in Katowice.

The parties of the first agreement dated 1 March 2010 are WAMAG S.A. – the Contractor and Kompania Węglowa S.A. - the Orderer.

The subject of the first agreement is supply of a complete bar screen for preliminary classification of raw coal to Zakład Przeróbki Mechanicznej Węgla KW S.A. Oddział KWK Bolesław Śmiały.

Net value of the first agreement: PLN 234.000,00

Term of the first agreement: till 30.06.2010

The parties of the second agreement dated 22 February 2010 are WAMAG S.A. – the Seller and Kompania Węglowa S.A - the Buyer.

The subject of the second agreement is supply of a spare parts for screens to KWK Jankowice in 2010.

Net value of the second agreement: PLN 131.207,00

Term of the second agreement: till 31.12.2010

The parties of the third agreement dated 22 February 2010 are WAMAG S.A. – the Seller and Kompania Węglowa S.A - the Buyer.

The subject of the third agreement is supply of a spare parts for screens to KWK Rydułtowy-Anna in 2010.

Net value of the third agreement: PLN 83.690,00

Term of the third agreement: till 31.12.2010

The parties of the fourth agreement dated 22 February 2010 are WAMAG S.A. – the Seller and Kompania Węglowa S.A - the Buyer.

The subject of the fourth agreement is supply of a spare parts for screens to KWK Chwałowice in 2010.

Net value of the fourth agreement: PLN 61.150,00

The parties of the fifth agreement dated 22 February 2010 are WAMAG S.A. – the Seller and Kompania Węglowa S.A - the Buyer.

The subject of the fifth agreement is supply of a spare parts for screens to KWK Marcel in 2010.

Net value of the fifth agreement: PLN 47.500,00

Stipulated penalties for all 5 agreements:

Each party is obligated to pay a stipulated penalty amounting to 10% of the gross value of unperformed part of the agreement in case of backing out of the agreement due to the reasons caused by that party. Apart that the parties may claim on general legal basis up to the value of the losses borne in fact. Detailed conditions of the agreement stick to the conditions commonly applied in the agreements of this kind.

A criterion of recognizing an agreement as a significant one is its transgression of a 10% bound of the Issuer's equity capital (the Issuer's equity capital, according to the interim report for fourth quarter 2009, amounts to PLN 1.319.861) and fulfillment of the criteria set forth in Par.2, Cl.1.44 and Par.2 Cl.2 of the Minister of Finance Regulation dated 19 February 2009 on current and periodic information (...). In the past 12 months the Issuer subsidiaries have signed with this customer and its subsidiaries agreements amounting altogether to PLN 133.470 thou, including this one. The Issuer informed about the last agreement signed with this customer in the current report RB 29/2010 dated 9.03.2010. The highest value agreement from among all the agreements signed in the past 12 months is the agreement the Issuer informed about in the current report RB 90/2009 dated 11.05.2009 that also contains information relating to the highest value agreement set forth in Par 9 Cl. 1-7 of Regulation by the Minister of Finance dated 19 February 2009 on current and periodic information (...).

Legal basis: Par.5 Cl.1.3 in connection with Par.2 Cl.2 and Par.9 of the Minister of Finance Regulation dated 19 February 2009 on current and periodic information conveyed by issuer of securities and conditions of recognizing as equivalent information requested by legal regulations of a country that is not a member country (*Dz.U. z 2009, Nr 33 poz.259*).
