Subject: Domestic agreement of the Issuer's subsidiary.

Legal basis: Law on Offer, Art. 56, Par.1 Item 1 – current and cyclic information

Contents of the report:

The Management Board of KOPEX SA with a registered seat in Katowice (the Issuer) informs that today has been aware of receiving on 9 March 2011 by WAMAG SA with a registered seat in Wałbrzych (the Issuer's subsidiary) an agreement signed with Kompania Węglowa SA based in Katowice.

The Parties of the agreement dated 28 February 2011 are consortium of the following companies: WAMAG SA (Consortium Leader) and Poland Investments 7 Sp. z o.o. (the Issuer's indirect subsidiary; Consortium Participant) – Contractor and Kompania Węglowa SA –Orderer.

Subject of the agreement is supply of vacuum pump with a capacity of 100-105m3/min for the Bielszowice Coal Mine.

Net value of the agreement: PLN 147,000.00

Term of the agreement: till 31.05.2011

Stipulated penalties: The Contractor is obliged to pay the Orderer stipulated penalties amounting to 10% of the net value of the subject of the agreement, in case of renouncing the agreement by one of the party due to the reasons caused by the Contractor. The Orderer is obliged to pay the Contractor a stipulated penalties amounting to 10% of the net value of the subject of the agreement in case of renouncing the agreement by the Contractor due to the reasons caused by the Orderer. Regardless of the stipulated penalties the Orderer retain the right to claim on Civil Code basis if the damages caused by non-execution or improper execution of the agreement exceeds the value of the stipulated penalties.

The criterion of recognising an agreement as a significant one is exceeding by it of 10% of bounds pertaining to the Issuer's equity capital (the Issuer's equity capital amounts to 1,346,518 thou PLN, in compliance with data included in the published report for Q4 2011) and fulfillment of the criteria set forth in Par.2 Cl.1 Item 44) and Par.2 Cl.2 of Regulation of the Minister of Finance dated 19 February 2009 on current and periodic information (...). In the past 12 months the Issuer's subsidiaries signed with this customer and its subsidiaries agreements amounting altogether to 175,075 thou PLN (including this one). The Issuer informed about the last agreement with this customer in the current report RB 22/2011 dated 8.03.2011. The highest value agreement from among all the agreements signed in the past 12 months is the agreement the Issuer informed about in the current report RB 66/2010 dated

2.08.2010 that also includes information relating to the highest value agreement set forth in Cl.9 Items from 1) to 7) of the Minister of Finance Regulation dated 19 February 2009 on current and periodic information (...).
