Subject: **Domestic agreement of the Issuer's subsidiary**

Legal basis: Law on Offer, Art. 56, Par.1 Item 1 – current and cyclic information

Contents of the report:

The Management Board of KOPEX SA with its registered seat in Katowice (the Issuer) informs that today has been aware of receiving on 15 June 2011 by Rybnicka Fabryka Maszyn RYFAMA SA with its registered seat in Rybnik (the Issuer's subsidiary) an agreement signed with Jastrzębska Spółka Węglowa SA based in Jastrzębie Zdrój.

The Parties of the agreement dated 6 June 2011 are Rybnicka Fabryka Maszyn RYFAMA SA – Contractor and Jastrzębska Spółka Węglowa SA, Zakład Logistyki Materiałowej – Orderer.

Subject of the agreement is supply of sliding sheets.

Net value of the agreement: PLN 124,100.00

Term of the agreement: 31.07.2011

Stipulated penalties: In case of renouncing the agreement by the Orderer due to the reasons caused by the Contractor and if the Contractor did not perform the agreement despite the expiry of the release of goods, the Orderer will be entitled to stipulated penalties amounting to 10% of the gross value of the unperformed part of the agreement. Detailed conditions of the agreement stick to the conditions commonly applied to the agreement of this kind.

The criterion of recognising an agreement as a significant one is exceeding by it of 10% of bounds pertaining to the Issuer's equity capital (the Issuer's equity capital amounts to 1,344,750 thou PLN, in compliance with data included in the published report for Q1 2011) and fulfillment of the criteria set forth in Par.2 Cl.1 Item 44) and Par.2 Cl.2 of Regulation of the Minister of Finance dated 19 February 2009 on current and periodic information (...). In the past 12 months the Issuer's subsidiaries signed with this customer and its subsidiaries agreements amounting altogether to 258,198 thou PLN (including this one). The Issuer informed about the last agreement with this customer in the current report RB 74/2011 dated 13.06.2011. The highest value agreement from among all the agreements signed in the past 12 months is the agreement the Issuer informed about in the current report RB 66/2011 dated 31.05.2011 that also includes information relating to the highest value agreement set forth in Cl.9 Items from 1) to 7) of the Minister of Finance Regulation dated 19 February 2009 on current and periodic information (...).
